FEES FOR SPRING TERM COMMENCING JANUARY 2025

WMS admits children from the ages of 2 up to 5 years old.

Government funding: Subject to availability of places, funded hours may be claimed at WMS for 3 hours per day by those on 15 hour schemes and for 6 hours per Full Day for those on 30 hour schemes. All other hours are charged at £11 per hour.

Please note that, where applicable, the fees set out in this document include a Consumables and Additional Activities charge made for each day on which funded hours are claimed. This covers those items which WMS provides in addition to core childcare services in accordance with the relevant contract terms and conditions.

MINIMUM WEEKLY ATTENDANCE OPTIONS

*Days four and five for those on 30 hour schemes do not have to be Full Days but can be 0800-1500, 0800-1745 or 0930-1745.

Due to the planning of staffing:

- all parents must commit to the same attendance pattern for the whole term; and,
- if your child is attending sessions on 2 or 3 days a week, we generally will require that at least one of those days is a Monday or a Friday.

SCHOOL HOURS & SESSION TIMES

WMS is open from 8am to 5.45pm. Pick-up times are 12.30pm, 3pm and 5.45pm.

Session times:	9.30 am	to	12.30 pm	"Morning"
	9.30 am	to	3.00 pm	"School Day"
	8.00 am	to	5.45 pm	"Full Day"

Extra hours:

Subject to the minimum attendance options, if you need early starts and/or late finishes you may add the following hours to your child's attendance pattern:

8.00 am to 9.30 am "Early Start"
 3.00 pm to 5.45 pm "Late Finish"

IMPORTANT POINTS TO NOTE

- Published fees are correct for the forthcoming term and are subject to change for subsequent terms.
- Fees are calculated over a 38 week school year and divided by 3 terms to give a termly figure.
- WMS charges a registration fee of £75.
- A deposit of £500 is payable upon acceptance of a place and is returnable when your child leaves the school, subject to the correct notice being given and all fees being paid up to date.
- Fees are subject to a late payment charge of £50 per outstanding week.
- Fees should be paid by bank transfer - cheques are not accepted.
- Late collection of children - WMS staff are employed and paid for school hours only, as a result of which late collection fees are charged at £10 per ten minutes late.

GIVING NOTICE TO LEAVE

Please remember that upon accepting a place at the school you are entering into a contract as set out in the relevant WMS Terms and Conditions, which require you to give in writing notice to terminate or reduce your child's place at the school.

Full fees are payable where the notice provision has not been complied with.

Should you be in receipt of funding for your child's place you are nevertheless liable for the full cost of a place at the school should you remove your child during a term or without giving a full term's notice such that we cannot claim the funding for your child. Should that situation arise you will be invoiced for the full cost of the place.

For your guidance the notice dates are:

- The first day of the Summer Term in April (if your child is not returning in September)
- The first day of the Autumn Term in September (if your child is not returning in January)
- The first day of the Spring Term in January (if your child is not returning in April)
